Dear Ms. Ndudane, Dr. El-Hassani and Mr. Oliver:

This booklet represents the 10,000 plus voices of scuba divers galvanized by Project AWARE and conservation partners in a shared effort to bring your attention to the critical decisions with respect to **shortfin make sharks** taking place at the meeting of the International Commission for the Conservation of Atlantic Tunas (ICCAT) (14-22 November in Marrakech, Morocco).

Project AWARE is an international non-profit ocean conservation organization supported by an extensive network of scuba divers around the world. Our constituents share a unique, underwater perspective on the value of keeping shark populations healthy. Working with a number of partner organizations around the world, we maintain a special focus on shark (and ray) conservation due in large part to the low reproductive capacity that leaves most of these species exceptionally vulnerable to overexploitation. Together, we work to promote shark fishing limits based on scientific advice and precautionary approach as well as compliance with best practices.

Shortfin makos are among the most vulnerable and valuable sharks taken in high seas fisheries and unlimited landings by top mako fishing countries have taken their toll on Atlantic populations. Over 10,000 scuba divers from around the world are calling on you - South Africa, Egypt and United States - to lead the way toward securing a ban on landing Atlantic makos before it's too late.

The new ICCAT population assessment for Atlantic shortfin make sharks (Isurus oxyrinchus) has revealed alarming trends. In particular, the North Atlantic population has been significantly depleted, and overfishing continues. In order to have a reasonable chance (54% probability) of rebuilding by 2040, catches must be cut to zero. Accordingly, ICCAT's Standing Committee on Research and Statistics (SCRS) has recommended a "complete prohibition of retention" as an immediate step to stop overfishing and begin the long recovery. Measures to minimize make discard mortality have also been advised, as additional, needed steps. High post-release survival rates (70%) make retention bans effective for dramatically reducing make mortality. Although South Atlantic population status is less clear, a retention ban is prudent in the face of this uncertainty, especially in light of the species' vulnerability, enforcement challenges, and lessons from the North.

We count on your leadership to help secure an Atlantic-wide, complete prohibition on shortfin make retention, and additional measures to minimize incidental mortality and improve data. It's make or break time for makos. Please step up now.

Our coalition aims to secure through RFMOs and follow-up national actions:


- Shark and ray catch limits that align with scientific advice;




Divers from 130 Countries & Territories

Top 10 Countries plus Egypt















